- I. Call Meeting to Order

- II. Approval of Minutes from July Meeting

- III. Treasurer Report & Membership Dues Update
 - \$7,677.26 in the account
 - Have deposited \$1200 worth of golf related funds
 - We have 3 teams signed up so far for the golf tournament
- IV. Golf Tournament Update Spike

- X. Guest Speaker Connie Hudson, Mobile County Commissioner
 - Love the exciting things that are happening in Mobile
 - o The first azalea came over from Toulouse, France
 - Since 2011, the occupancy rates have gone up close to 10% through 2018
 - Sports Tourism has long been an important aspect of not only our community but also across the country. Even during the recession, sports tourism was one that didn't suffer any ill effects while people weren't spending money in other areas.
 - For the better part of the last two decades, the soccer community has trying for more facilities. Soccer has continued to grow despite not having many facilities.
 - The new soccer facility in Mobile has been about an 8 year endeavor.
 - Started the concept back in 2012 after listening to the soccer community about wanting this recreational venue. They looked at different areas where a facility could be located. It wasn't easy when looking at what would be accessible to the interstate and infrastructure that we have in place such as hotels, restaurants, & shops.
 - Location, infrastructure, and price were considerations. Another consideration was almost everywhere they looked wetlands was there somewhere. They landed on this property off of Halls Mill Rd & I-10 & I-65 with about 200 acres. Her first plan was to buy all of it. We were going

to anchor it with a soccer complex with 10 fields and 1 large championship field. They were going to pattern it after the complex in Decatur, the Jack Allen Soccer complex. The soccer community wanted something like that. They wanted top quality. That is expensive.

- o In the original plan, there was a portion of wetland area that they were going to use as natural habitat, walking trail, or golf. These were things that didn't require land disturbance. The plan was to put a water park in over 15 acres. That fell apart. She couldn't get the political support to support that idea. Had look at other alternatives.
- There wasn't a location that was better. So the plan was to build this in a phase approach instead of all at once. We needed to get it started. They redesigned with this new approach in mind. After about 5 years, she was able to get it started by purchasing the initial 60 acres of the property and get the design drawn. This was enough for 2 tournament quality lighted fields and two seated fields. That meant there would be 2 finished fields and 2 seated fields. This was part of the pay-as-you-go money. This initial design included permeable parking.
- Most recently they had another 1.5 million that could be put towards it. So they revised it to include 3 finished lighted fields and it had to be on the same footprint as before in order to avoid rebidding. That left them with the ability to do a seated practice field, a regular size standard field, and a small youth practice field.
- o By January, we will end up with this completed. The entrance initially will be off of Lees Lane. They will still be working. Halls Mill Rd will have a 3rd turn in lane. They will be working over the next year to extend roads.
- They have received grants towards this effort. There has also been a lot of local community support towards this effort.
- o There will be two artificial turf fields and the championship field will be one of them. It will have a better quality lighting, bleachers, locker rooms, and rest rooms. The price tag on that is 1.7million. A letter has been sent to the mayor requesting this money.
- The city will actually end of better with revenue generation from the venue than the county will.
- After this first phase is complete, they will be depleted of money that has been put aside for this project. She has been talking to people to get more funds but hasn't seen anything yet. For a regular field, it cost \$600,000.
 For an artificial turf field, it will run around 1.2 million.
- o The first phase will be finished in January. The Mobile United Football club is the largest soccer club in Mobile County and includes about 800

members. They will help manage and operate the complex. They might have some county staff working there helping them but they will be responsible for scheduling and ensuring maintenance is performed properly.

- Comment from the audience: We need to do better as a community maintaining our parks. We can build it all day but we need to maintain them.
- O Question from the audience: Have they started booking tournaments in yet?
 - No. Not yet. We don't have a management agreement set up with Mobile United yet. They are just working with her right now. They will be working on that agreement before the end of the year to get that in place.
- Question from the audience: They will not be multi-purpose fields?
 Correct?
 - They will be multi-purpose for lacrosse and rugby but primarily for soccer.
- Ouestion from the audience: Hank Aaron Stadium use?
 - That is owned by the city. Had heard at one point about putting Top Golf facility there but unsure.
